AN ORDINANCE OF THE CITY OF RICHLAND, WASHINGTON, ADOPTING THE 2025 ANNUAL BUDGET FOR THE CITY OF RICHLAND, INCLUDING THE 2025-2030 CAPITAL IMPROVEMENT PLAN.

## **BE IT ORDAINED** by the City of Richland as follows:

<u>Section 1. Budget Adopted</u>. The Annual Budget of the City of Richland for the year 2025, including the 2025-2030 Capital Improvement Plan, and each and every fund thereof as fixed and determined in the Proposed Budget for the year 2025, as revised by the City Council, is hereby adopted as the Budget of the City for the calendar year 2025. The total cumulative salaries and wages set forthin in the budget document represent the maximum approved expenditure, subject to the requirements and limitations set forth in the Compensation Plan for Unaffiliated Employees and Collective Bargaining Agreements for Affiliated Employees, or other contracts approved by Council. In the interests of operational efficiency and business need, the City Manager may amend salaries and wages within departments and divisions as long as the total labor budget is not exceeded.

Section 3. This Ordinance shall take effect the day following its publication in the official newspaper of the City of Richland.
