ORDINANCE NO. 2024-44

AN ORDINANCE OF THE CITY OF RICHLAND, WASHINGTON, AMENDING THE 2024 BUDGET TO PROVIDE FOR ADDITIONAL APPROPRIATIONS IN THE CITY'S GENERAL FUND, STREETS MAINTENANCE FUND, SPECIAL LODGING ASSESSMENT FUND, EQUIPMENT REPLACEMENT FUND, MEDICAL SERVICES FUND, PARKS PROJECT CONSTRUCTION FUND AND COMMUNITY DEVELOPMENT BLOCK GRANT FUND AND DECLARING THAT A PUBLIC EMERGENCY EXISTS IN CERTAIN OF THESE FUNDS.

WHEREAS, on November 21, 2023, Richland City Council approved Ordinance No. 2023-29 adopting the 2024 Budget; and

WHEREAS, certain additional revenue sources have been identified that were not anticipated when the 2024 Budget was approved, the expenditure of which is not included in current appropriations; and

WHEREAS, certain additional expenditures have been identified as necessary or desirable in the current year that do not have a specific new revenue source and no funds were appropriated for these expenditures; and

WHEREAS, sufficient unappropriated funds necessary to support the required budget adjustment are available; and

WHEREAS, a public hearing was held on December 3, 2024 regarding the proposed increase in appropriations from beginning fund balance as required by RCW 35.33.091.

NOW, THEREFORE, BE IT ORDAINED by the City of Richland as follows:

<u>Section 1</u>. Facts Constituting Emergency. The expenses contained within this Ordinance were not anticipated when the 2024 Budget was adopted.

<u>Section 2</u>. Declaration of Public Emergency. Due to circumstances described above, the City Council declares that a public emergency exists in the General Fund, Streets Maintenance Fund, Equipment Replacement Fund, Medical Services Fund and Community Development Block Grant Fund.

<u>Section 3</u>. Amendment of the 2024 Budget. The 2024 Budget is hereby amended to provide additional appropriations in the following funds, and from the following sources, as indicated:
