

RESOLUTION NO. 2025-14

**A RESOLUTION OF THE CITY OF RICHLAND, WASHINGTON,
AMENDING THE 2025-2030 SIX-YEAR TRANSPORTATION
IMPROVEMENT PROGRAM.**

WHEREAS, RCW 35.77.010 requires local jurisdictions to prepare and adopt a perpetual six-year Transportation Improvement Program (TIP); and

WHEREAS, on June 4, 2024, Richland City Council adopted Resolution No. 2024-76, approving and adopting the 2025-2030 TIP; and

WHEREAS, new transportation projects and updates to existing transportation projects are required to be adopted into the TIP in order to receive federal or state funding; and

WHEREAS, the South George Washington Way Pavement Preservation Project, which resurfaces George Washington Way from Columbia Point Drive to Bradley Boulevard, successfully received grant funding from the Washington State Department of Transportation (WSDOT) National Highway System Asset Management Program; and

WHEREAS, the George Washington Way Sidewalk Improvements Project, which adds sidewalk and slope stabilization on the east side of George Washington Way from Comstock Street to Bradley Boulevard, successfully received grant funding from the Washington State Transportation Improvement Board (TIB) Active Transportation Program; and

WHEREAS, the Systemic Stop-Controlled Intersections Safety Improvements Project - Phase 2 successfully received grant funding from the WSDOT City Safety Program; and

WHEREAS, the Duportail/Kennedy Intersection Improvements, Duportail/Driveway Intersection Improvements, and Queensgate Drive and Duportail Street Intersection Improvements Projects, known collectively as the Duportail Street Improvements Project, received grant funding from the TIB Urban Arterial Program; and

WHEREAS, adding and modifying projects on the 2025-2030 TIP requires Council action which will facilitate WSDOT and TIB processes and the release of funding; and

WHEREAS, as required by state law, Richland City Council held a public hearing on January 21, 2025 to receive public input on the proposed amendment to the 2025-2030 Transportation Improvement Program; and

WHEREAS, the City's best interests are served by amending the 2025-2030 TIP to continue the required steps in delivery of the above-referenced projects.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Richland that the 2025-2030 Six-Year Transportation Improvement Program is hereby amended as provided in **Exhibit A**, attached hereto and incorporated herein by this reference, to add or amend the following projects:


- Add South George Washington Way Pavement Preservation Project
- Add George Washington Way Sidewalk Improvements Project
- Modify Systemic Stop-Controlled Intersections Safety Improvements Project
- Modify Duportail/Kennedy Intersection Improvements Project
- Modify Duportail/Driveway Intersection Improvements Project
- Modify Queensgate Drive and Duportail Street Intersection Improvements Project.

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.


