

RESOLUTION NO. 2025-22

**A RESOLUTION OF THE CITY OF RICHLAND, WASHINGTON,
AUTHORIZING AN AMENDMENT TO THE 2025-2030 SIX-YEAR
TRANSPORTATION IMPROVEMENT PROGRAM FOR THE
SR-240/AARON DRIVE COMPLETE STREETS IMPROVEMENTS.**

WHEREAS, RCW 35.77.010 requires local jurisdictions to prepare and adopt a perpetual six-year Transportation Improvement Program (TIP); and

WHEREAS, on June 4, 2024, Richland City Council adopted Resolution No. 2024-76, approving and adopting the 2025-2030 TIP; and

WHEREAS, updates to existing transportation projects are required to be adopted into the TIP in order to receive federal or state funding; and

WHEREAS, the SR-240/Aaron Drive Complete Streets Improvement Project, which reconfigures the highway interchange to resolve a significant traffic choke point and improve pedestrian accessibility, successfully received Move Ahead Washington (MAWA) funds from the Washington State Legislature to be administered by the Washington State Department of Transportation (WSDOT); and

WHEREAS, adding and modifying projects on the 2025-2030 TIP requires Council action which will facilitate WSDOT processes and the release of funding; and

WHEREAS, as required by state law, Richland City Council held a public hearing on February 4, 2025 to receive public input on the proposed amendment to the 2025-2030 Transportation Improvement Program; and

WHEREAS, the City's best interests are served by amending the 2025-2030 TIP to continue the required steps in delivery of the project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Richland that the 2025-2030 Six-Year Transportation Improvement Program is hereby amended to incorporate modifications to the SR-240/Aaron Drive Complete Streets Improvement Project as attached in **Exhibit A**.

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.
