GENERAL SUMMARY

Performs administrative support work processing, updating, and maintaining documents, files, and other records in support of Police Services operations, and related work as apparent or assigned. Work is performed under the close supervision of the Police Records Supervisor (supervisor).

CORE VALUES

All employees are expected to model and foster the City of Richland's core values in the performance of their duties and their interactions while representing the City. The values of *Teamwork*, *Integrity*, and *Excellence* promote and maintain a high level of morale and productivity, and are the tie that binds all City employees together, across all functions.

ESSENTIAL JOB FUNCTIONS

To be successful in this position, an individual must be able to perform each essential function satisfactorily. Additional duties of a similar nature and level may also be assigned. The City may make reasonable accommodations to enable a qualified individual with disabilities to perform the essential functions.

- Processes a large volume of paperwork including case reports, arrest reports, logs, court records, warrants, warrant recalls, subpoenas, citations, and other related paperwork each requiring a specific detailed procedure and deadline; enters data into records, cross-indexes information between records, inputs information into computer records, databases, and files and maintains hard copies of data.
- Prepares, distributes and disseminates confidential criminal police records to the appropriate prosecuting authorities, courts and administrators; maintains police investigation reports, supplemental follow-ups, attachments, prosecution referrals, screening decisions, and case dispositions.
- Maintains criminal warrants and criminal and civil protection orders, including background research, criminal history, second checks, validation, dissemination,

confirmation, locates, detainers, removal, and distribution to appropriate law enforcement agencies, correctional facilities and courts.

- Processes applications for concealed pistol licenses and gun purchases as required by State and Federal laws, including fingerprinting, receipt of funds, background research, and data entry.
- Processes and disseminates criminal history information (CHRI), report requests, and requests for public information to law enforcement, business, government agencies and the general public.
- Enters non-emergency calls for service (officer contact) into the law enforcement CAD system per requests by phone and lobby contacts.
- Provides fingerprinting services to the general public, City employees, and other agencies.

KNOWLEDGE, SKILLS AND ABILITIES

The requirements listed below are representative of the knowledge, skill, and/or ability required to successfully perform the essential functions of the position.

Knowledge of:

- Applicable Federal, State, and local laws, rules, codes, and regulations related to assigned activities.
- Department's mission, methodologies, and policies in general, including specific procedures and deadlines covering the vast variety of paperwork in the handling of police records.
- Roles and responsibilities of police officers and command staff.
- Alpha and numeric filing systems.
- Financial and statistical record-keeping techniques.
- Word processing and desktop publishing software applications used by the City.
- Proper telephone techniques and etiquette.
- Modern office practices, methods, procedures, and equipment.
- Record-keeping and inventory principles, procedures, and techniques.
- Correct English usage, grammar, spelling, punctuation, and vocabulary.

Skills and Abilities to:

- Learn, interpret, apply, and explain laws, codes, regulations, policies and procedures applicable to assigned tasks.
- Learn department and program objectives and goals.
- Work in an extremely fast-paced environment and complete work with minimal errors.
- Maintain a high degree of confidentiality.
- Maintain accurate logs, records, files, and filing systems pertinent to tasks.

- Work shifts covering 24/7 operation, including nights, weekends, and holidays.
- Perform administrative support and clerical accounting duties with speed and accuracy.
- Understand and work within scope of authority.
- Transcribe material from transcription machine tapes or notes; type 35 WPM with accuracy; perform data entry with speed and accuracy.
- Use good judgment and remain calm, objective, positive, and empathetic despite pressures from citizens or officers in critical, emotion-laden situations.
- Communicate effectively both orally and in writing; comprehend and use English effectively including producing all forms of communications in a clear, concise, and understandable manner to intended audiences.
- Organize and prioritize a variety of projects and multiple tasks in an effective and timely manner; work independently with little or no direction, set priorities, and meet critical time deadlines.
- Operate modern office equipment including personal computer equipment using standard or customized software application programs appropriate to assigned tasks.
- Use tact, initiative, prudence, and independent judgment within general policy, procedural and legal guidelines.
- Establish, maintain, and foster positive and effective working relationships with those contacted in the course of work.

PHYSICAL REQUIREMENTS AND WORKING ENVIRONMENT







The work environment characteristics described are representative of those an employee encounters while performing the essential functions of this job. The physical demands described below are representative of those that must be met by an employee to successfully perform the essential functions of the job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

This work requires regular and punctual attendance at the office or other assigned locations; occasional exertion of up to 25 pounds of force; work frequently requires sitting, speaking, or hearing, using hands to finger, handle or feel, and repetitive motions, frequently requires walking and pushing or pulling and occasionally requires standing, climbing or balancing and reaching with hands and arms; work has standard vision requirements; vocal communication is required for expressing or exchanging ideas by means of the spoken word; hearing is required to perceive information at normal spoken word levels; work requires preparing and analyzing written or computer data and observing general surroundings and activities; work has no exposure to environmental conditions; work is generally in a moderately noisy location (e.g. business office, light traffic).
