ORDINANCE NO. 2025-08

AN ORDINANCE OF THE CITY OF RICHLAND, WASHINGTON, AMENDING THE 2025 BUDGET TO PROVIDE FOR ADDITIONAL APPROPRIATIONS IN THE CITY'S GENERAL FUND, INDUSTRIAL DEVELOPMENT FUND, PARK RESERVE FUND, STREETS CAPITAL CONSTRUCTION FUND AND PARK PROJECT CONSTRUCTION FUND AND DECLARING THAT A PUBLIC EMERGENCY EXISTS IN THE CITY'S GENERAL FUND, INDUSTRIAL DEVELOPMENT FUND AND PARK RESERVE FUND.

WHEREAS, on November 19, 2024, Richland City Council approved Ordinance No. 2024-37 adopting the 2025 Budget; and

WHEREAS, this Ordinance No. 2025-08 will address several budget adjustments occurring in various funds; and

WHEREAS, Resolution No. 2024-119 authorized the acceptance of a grant of up to \$10,000 from the Washington Traffic Safety Commission (WTSC) for the purchase of traffic safety law enforcement equipment; and

WHEREAS, upon award of the grant, WTSC awarded additional funds of \$6,325 for a total amount of \$16,325; and

WHEREAS, Resolution No. 2025-35 authorized the City Manager to sign and execute a memorandum of understanding with the Seattle Police Department for the purchase of forensic hardware, software, and training for use in Internet Crimes Against Children (ICAC) Task Force investigations; and

WHEREAS, additional appropriations in the amount of \$91,325 are needed in the General Fund to authorize the spending of the above grants; and

WHEREAS, Resolution No. 2024-169 authorized a phased, multi-property land exchange between the City of Richland and the Port of Benton; and

WHEREAS, Phase I properties closed on January 7, 2025; and

WHEREAS, additional environmental testing is desired before closing on Phase II properties, which is estimated to cost \$168,249 from the Industrial Development Fund; and

WHEREAS, additional General Fund appropriations in the amount of \$300,000 are required to temporarily loan funds to the Richland Housing Authority to resolve outstanding federal loan obligations and complete winding down by divesting of the remaining assets; and

- **WHEREAS**, the 2023 Budget included a capital improvement project to construct an outdoor space at the Richland Public Library, which has been carried forward to the current year; and
- **WHEREAS**, inflationary factors and higher than anticipated bids have resulted in the need to reengineer the project and seek additional funds in the amount of \$118,157; and
- **WHEREAS**, the Park Reserve Fund has adequate reserves to pay for the additional costs, which will be transferred from the Parks Reserve Fund to the Park Project Construction Fund; and
- WHEREAS, Council previously authorized the acceptance of several grants for transportation as follows; \$1,307,000 federal grant for pavement preservation on South George Washington Way from Columbia Point to Bradley; \$850,000 State Transportation Improvement Board (TIB) grant for sidewalk improvement on George Washington Way from Comstock to Bradley; \$1,024,000 federal grant for pavement preservation on South George Washington Way from Bradley to Guyer; \$306,201 State TIB grant for Queensgate and Duportail intersection improvements; and \$633,232 State TIB grant for Duportail and Kennedy intersection improvements; and
- **WHEREAS**, additional appropriations in the amount of \$4,120,433 are needed in the Streets Capital Construction Fund to authorize spending of the grant awards; and
- **WHEREAS**, no funds were appropriated in the General Fund, Industrial Development Fund, Park Reserve Fund, Streets Capital Construction Fund or Park Project Construction Fund for the purposes identified herein; and
- **WHEREAS**, sufficient unappropriated funds are available in the General Fund, Industrial Development Fund and Park Reserve Fund to support the required budget adjustments; and
- **WHEREAS**, pursuant to RCW 35.33.091, a duly noticed public hearing was held on April 1, 2025 regarding the increase in appropriations from beginning fund balance in the above-referenced funds.

NOW, THEREFORE, BE IT ORDAINED by the City of Richland as follows:

- <u>Section 1</u>. The City Manager is authorized to receive additional grant funds from the Washington Traffic Safety Commission in the amount of \$6,325.
- <u>Section 2</u>. Facts Constituting Emergency. The expenses contained within this Ordinance were not anticipated when the 2025 Budget was approved.
- <u>Section 3</u>. Declaration of Public Emergency. Due to circumstances described above, the City Council declares that a public emergency exists in the General Fund, Industrial Development Fund, and Park Reserve Fund.
- <u>Section 4</u>. Amendment of the 2025 Budget. The 2025 Budget is hereby amended to provide additional appropriations in the General Fund, Industrial Development Fund, Park Reserve Fund,
